I understand that I/my child may be subject to bites, scratches, infections, illness or other maladies as a result of my activities, participation and /or interactions with animals at the Humane Society of Greater Dayton (HSGD), Meowza Cat Boutique (Meowza) or during activities or events where HSGD or Meowza are present.
