3. I willingly agree to comply with the stated and customary terms and conditions for participation, I will remove myself from participation and bring such to the attention of the Company immediately; and,

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS RiversEdge Outfitters Incorporated their officers, officials, agents, and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity ("Releasees"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presences or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

I also agree to be responsible for each canoe, kayak, raft, paddle, and life jacket rented and if lost or stolen will pay the replacement value of \$500.00 for each canoe, \$300.00 for each kayak, \$1000.00 for each raft, \$15.00 for each paddle, and \$20.00 for each life jacket. I further agree to return said equipment to RiversEdge Outfitters in the same general condition at the expiration of the rental period (ordinary wear and tear expected). I also agree to return by the posted times or pay a fee of \$10.00 per half hour per boat. If payment was made by credit card I understand this fee will be charged to my credit card.
